- ii. **Technical Bid**: This bid (to be complied in full) should only include technical terms (Annexure-1), Commercial terms and conditions (Annexure-2a/2b) and Public Procurement (Preference to Make in India) (Appendix-A). This bid should not contain any price details. If prices are indicated in the technical bid or attached as a part of technical bid even in the form of PDF, the offer will not be considered for evaluation.
- iii. Refer Appendix-A of RFQ 'Public Procurement (Preference to Make in India). The offers sought from all suppliers i.e. Class-I, Class-II Local supplier, Non-local suppliers/ foreign supplier).
