- i) Repair wherever needed and whitewashing of approx area of 216 sqm
- ii) Removal of old carpet sheet and laying of new linoleum sheet of approx area of 58 sqm
- iii) Replacement of old beading on edges of floor with new one of length of 55 meter
- iv) Fixing of new tiles in washroom and toilets of approx area of 23 sqm
- v) Removal of old tiles on floor and wall and fixing of new one in kitchen/washrooms
- vi) Miscellaneous work of replacement of WC, shower, shower curtain, tap, shower pipes, washbasin tap and related works
- vii) Replacement of 4 led lights in bedrooms and 2 lights in washrooms
