

Embassy of India, Moscow (Russia)
Notice Inviting Bids

1. The Embassy of India, Moscow invites bids from interested contractors for repair/painting at Kutuzovsky Prospect 7/4, Korpus 6, Flat No.49, Moscow (Russian Federation).

2. The work description is as follows:

a. Scraping, repair and painting of walls including ceilings in hall, Dining rooms and Passage area, except one wall of drawing room and one wall of dining room, where wall paper is already pasted (approximate surface area for painting 190 sq(m)).

b. Painting of two bath room doors.

c. Replacement of Bath Cabin (Size 110x80x210 cms) along with Water Mixture in small bath room near kitchen

4. Arresting Leakage on sides of Bath tub in main bath room near bedroom.

3. Schedule of payment for the work will be as follows :

a. Mobilization advance of 30% of the total value to be paid within 3 days of the signing of the contract. The contractor will be required to furnish bank guarantee for the same amount.

b. Second installation of 20% of the total value on commencement of the work.

c. Third installation of 50% of the total value of the work to be paid on completion of the work to the satisfaction of the Embassy of India.

d. Any delay in the completion of work beyond the agreed duration would lead to deduction in payment @1% of total value of contract per day of delay.

4. Interested parties may visit the site and measure the area or scope of work for formulating their quotation from 01.10.2020 to 21.10.2020. Prior appointment should be made with Technical Wing of Embassy of India (Tel. No.495-7837535/ Extn 277) for this purpose.

5. Contractors are required to submit their bids in two separate sealed envelopes as follows:-

a. The first envelope should be marked "Technical Bid" and should contain the technical description of the work, material used, methodology and duration of the work.

b. The second envelope should be marked " Financial Bid" and should contain the total cost of work along with detailed breakup of costs.

c. It may be noted that the quotation should be valid for a period of six months.

6. Both the sealed envelopes should be submitted to Technical Wing, Embassy of India, Moscow latest by 21.10.2020 before 14.00 Hrs accompanied with the proof of payment of RbIs 30,000/- to the Embassy of India, Moscow vide bank Transfer (Bank details can be obtained from the Embassy while visiting the site for inspection). The amount of RbIs. 30,000/- will be treated as earnest money and would be returned to all the unsuccessful bidders within three working days of the opening of the bid.

7. Representatives of all the bidding parties can be present at the time of the opening of the bids. The technical will be opened on 21/10/2020 at 17.00 Hrs at the Embassy of India, Moscow, Vorontsovo Pole, 6-8. After the examination of the technical bid by the Tendering Committee of the Embassy, the Financial bids of only those parties will be opened whose technical bids are found acceptable by the Tendering committee. The financial bids will be opened at 17.30 Hrs and the same day, work will be offered to the lowest bidding party.
