

Rules:

1. GENERAL PROVISIONS

1.1. A public competition called **“Contest for Indian Nationals in Russia!”** (hereinafter referred to as the Rules - the Competition) is held as part of the social media campaign of the Indian Embassy in Russia (hereinafter - the Promotion).

1.2. The competition is held throughout the Russian Federation according to the rules of an open public competition for Indian nationals living in Russia. Within the framework of the Competition, participants can submit their entries through the link specified in the Competition description. All information about the Competition is presented on the community page of the Embassy of India in Russia on Facebook [<https://www.facebook.com/IndiaInRussia/>].

2. COMPETITION ORGANIZER

The organizer of the competition is the Embassy of India in Moscow (hereinafter - the "Organizer").

3. DATE OF THE COMPETITION

3.1. Registration of persons for participation in the Competition is held on the page in the Google Forms (<https://forms.gle/2MaV83KT34j1pmQz6>) since: 10:00 on April 3, 2020 before the 23:59 25 Apr 2020 (inclusive). From the moment a person registers on a page in Google Forms (<https://forms.gle/2MaV83KT34j1pmQz6>), he becomes a Participant in the Contest (hereinafter referred to as the Participant).

3.2. By registration in the Competition is meant the sending of a creative assignment.

3.3. Summing up the results and determination of winners of the Competition The Organizer no later than 30 April, 2020. The results of the Competition are published on the community page of the Embassy of India in Russia on Facebook (<https://www.facebook.com/IndiaInRussia/>) .

3.4. Presentation (sending) awards shall be made within a month from the date of determination of wins of Competition, but not later than 24 May 2020.

4. PARTICIPANT OF THE COMPETITION

4.1. To participate in the competition citizens of Russian Federation and the Republic of India shall be at least 8 years years old.

4.2. By sending the work to the specified link, the Participant confirms that he has read and agreed to these Rules for the Competition.

4.3. By submitting the works by reference , the Contest participant thereby confirms that he gives the consent of the Embassies of India in Moscow and his authorized representatives to receive,

collect, systematize, accumulate, store, specify (update, modify), use and otherwise process (including including in electronic form) his personal data specified during registration , as well as those indicated in the scanned copy of the document sent by the winner to the Organizer in accordance with clause 5.3.1 of these Rules. Consent is given for the duration of the Competition and within three years from the end date for the receipt of prizes. Consent may be revoked at any time by sending a notification by e-mail to the Organizer .

Withdrawal of consent to the processing of personal data is considered a refusal to participate in the Competition.

4.4. By submitting the works by reference , the Contest participant thereby confirms that he agrees to the Organizer to send him correspondence related to this Competition, as well as the Organizer's advertising information, to the address indicated during registration.

4.5. By submitting the works by reference , the Contest participant thereby confirms that in case of winning the main or incentive prizes, he gives the Organizer consent to post information in the manner and amount specified in clause 8.4. Of the rules.

5. RIGHTS AND OBLIGATIONS OF THE COMPETITION PARTICIPANT

Participants of the Competition have rights and obligations in accordance with the legislation of the Russian Federation and these Rules.

5.1. The participant of the Competition has the right:

5.1.1. Get acquainted with these Competition Rules in the account information and receive information about the Competition .

5.1.2. Take part in the Competition in the manner specified by these Rules.

5.1.3 . Get a prize if recognized as the winner of the Competition.

5.1.4 . The winner of the Competition automatically loses all of its rights to receive a prize if a notification is sent to the Organizer 's email about refusing to receive a prize to the Competition Organizer.

5.2. Participant of the Competition is not entitled to:

5.2.1. Require the Contest Organizer to receive the cash equivalent of a prize.

5.2.2. Use materials related to participation in the Contest for any commercial purposes - however, this does not impose restrictions on the use of these materials for your own non-commercial purposes.

5.3 . Participant of the Competition is obliged:

5.3.1. If the Participant is recognized as the winner of the main prize (in accordance with clause 8.5 of these Rules), upon the request of the Organizer, provide an identity document by sending a

scanned copy of the document to the personal messages of the account of the Embassy of India in Moscow.

5.3.2 . The winner of the Competition independently pays all taxes related to receiving the main prize established by the current legislation of the Russian Federation. From the moment of receiving the main prize, the winner is solely responsible for paying all taxes and other existing mandatory payments related to its receipt established by the current legislation of the Russian Federation.

5.4. Requirements and restrictions for participation in the competition :

5.4.1. Works are accepted only from real people .

5.4.2. To participate in the competition, entries are not allowed , the content of which is contrary to the laws of the Russian Federation in particular , the text should not have en directly or indirectly:

[5.4.2.1](#) . disrespect society;

[5.4.2.2](#) . offend the religious feelings of believers;

[5.4.2.3](#) . serve as the propaganda of the use (distribution) of alcoholic beverages, tobacco products;

[5.4.2.4](#) . defame the honor and dignity of citizens;

[5.4.2.5](#) . induce unlawful acts, cruelty or violence;

[5.4.2.6](#) . have erotic content;

[5.4.2.7](#) . in any way to report on the attractiveness of non-traditional sexual relations or to arouse interest in such relations, or to form a distorted idea of the social equivalence of traditional and non-traditional sexual relations;

[5.4.2.8](#) . contain scenes of unlawful acts, cruelty or violence;

5.4. 3 . Also, materials whose content is contrary to the Federal Law "On the Protection of Children from Information harmful to their Health and Development", namely, images and texts that are not allowed, are not allowed to participate in the Contest, which:

[5.4. 3 . 1](#) . encourage children to commit actions that pose a threat to their life and (or) health, including harming their health and suicide;

[5.4. 3 . 2](#) . they can cause children to desire to use narcotic drugs, psychotropic and (or) stupefying substances, tobacco products, alcoholic and alcohol-containing products, beer and drinks made on its basis, take part in gambling, engage in prostitution, vagrancy or begging;

[5.4. 3 . 3](#) . substantiate or justify the permissibility of violence and (or) cruelty, or induce violent acts against people or animals;

[5.4. 3 . 4](#) . deny family values and form disrespect for parents and (or) other family members;

[5.4. 3 . 5](#) . justify illegal behavior;

[5.4. 3 . 6](#) . contain foul language;

[5.4.3.7](#) . contain pornographic information.

6. RIGHTS AND OBLIGATIONS OF THE COMPETITION ORGANIZER

6.1. The Organizer of the Competition is not entitled to provide information about the Participants of the Competition to third parties, unless it is necessary to organize the Competition, organize the delivery of prizes, etc. cases, as well as in cases stipulated by the legislation of the Russian Federation.

6.2. The Organizer of the Competition has the right:

6.2.1. At its discretion, unilaterally prohibit further participation in this Competition to any person who acts in violation of these Rules, acts in a destructive manner or takes actions with the intention of annoying, insulting, threatening or disturbing any other person that may be associated with this Competition. When determining the Winners and owners of the Prize, the Organizer does not take into account the Applications of the Participants, in respect of which the Organizer decided to remove them from participation in the Competition.

The Contest Organizer has the right at any time to exclude from the list of Participants or Winners persons who:

- Violated the rules of the Competition;
- Do not comply with the requirements provided for in section 4 of these Rules.

In accordance with the requirements of the current legislation of the Russian Federation 6.3. The Organizer acts as a tax agent in relation to the Bidders and submits to the tax authorities information on the income of individuals who have become prizes worth over 4,000 (four thousand) rubles. If the prize includes the monetary part of the prize, the Organizer calculates the tax on personal income and withholds it from the due monetary part of the prize in accordance with the current tax legislation of the Russian Federation for transferring it to the budget of the appropriate level.

6.4. The Organizer reserves the right not to enter into written negotiations or other contacts with the Bidders, except as provided for in these Rules, the current legislation of the Russian Federation.

6.5. At its discretion, unilaterally terminate, modify or temporarily suspend the Competition, if for some reason the Competition cannot be held as planned, including any reason not controlled by the Contest Organizer that distorts or affects performance, security, honesty, integrity or proper conduct of the Competition.

6.6. Contest Organizer reserves the right to change the rules of the Contest, without specifying the reasons for changes in the rules, but with the obligatory publication of news about changes in the Regulations on the community page community of the Embassy of India in Russia in Instagram [[https : //www.instagram.com/ india_in_russia /](https://www.instagram.com/india_in_russia/)] .

These changes will take effect from the date of their publication in the account community of the Embassy of India in Russia in Instagram [https://www.instagram.com/india_in_russia/] .

6.7 . The organizer of the Competition is obliged:

6.7.1. Use the personal data of the Contest Participants exclusively in connection with this Competition and not provide information to third parties for purposes not related to the Competition.

7. ORDER OF PARTICIPATION IN THE COMPETITION

7.1. Those who wish to take part in the Competition, during the period specified in clause 3.1 of these Rules, must perform the following actions:

7.1.1 . Register on the page in Google Forms (<https://forms.gle/2MaV83KT34j1pmQz6>) , leaving all the requested data;

7.1.2. Within the form, send a link to the file exchange for your work that meets the requirements of the Organizer:

7.1.2. 1 . Creative task for one of the topics indicated by the Organizer: poetry, logo + slogan, digital art.

7.1.2. 2 . File format - any at the discretion of the Member.

7.2. The winner of the Competition is the Participant, whose competitive work will be selected by an independent jury of the competition, consisting of representatives of the Organizer of the competition in the amount of three people. The organizer reserves the right to change the method of determining the winner by notifying about it on the pages of the competition.

7.3. The participant can register in the competition, as well as send work not a limited number of times - but only under his own name.

7.4 if the Organizer reveals cases of the use of fake accounts by one participant, the Organizer has the right to block such a Member.

8. PROCEDURE FOR DETERMINING AND NOTICING THE COMPETITION WINNER

8.1. To summarize the results of the Contest and to determine the owner of her prizes The organizer Competition Commission is formed, consisting of no less than 3 (three) persons.

8.4. Definitely a winner she Competition is made within the period specified in 3.3. of these Rules.

8.5. The organizer in writing (in an electronic message) within the time period specified in clause 3.3. of these Rules, notifies the winner of her winning a prize and the procedure for its receipt. If

during this period the winners do not respond to the letter of the Organizer, Organizer may select at its discretion an alternate winner.

8.6. Information (name) of the winners of the competition, winning prizes, published on the community page of the Embassy of India in Russia on Facebook (<https://www.Facebook.Com/IndiaInRussia/>) no later than 30 April 2020.

8.7. To receive the prize, the winner must send an email to the Embassy of India within 3 calendar days (by mail or via Facebook - <https://www.Facebook.Com/IndiaInRussia/>)

- copies of the pages of your passport (spread with photo);

8.8. If the Organizer of the Competition reveals the fact that the Participant provided incorrect information about himself during registration, he is recognized as not fully complying with these Rules of the Competition. In this case, the Contest Organizer has the right to refuse to award a prize to such a Participant.

8.9. In case the winner refuses to receive the prize, or the Participant does not comply with these Rules, the Organizer has the right to transfer the prize to another Participant at his discretion, or dispose of the prize in another way that is not contrary to applicable law.

8.10. The Organizer is not responsible for non-receipt, including by the due date, from the Participants of letters and / or documents required to receive the prize of the Competition, for technical or other reasons beyond the control of the Organizer.

8.11. The Organizer is not responsible for errors / malfunctions when transmitting data via the Internet due to the fault of communication organizations, as a result of technical problems and / or fraud on the Internet, and / or communication channels used during the Competition, as well as for other reasons beyond the control of The organizer.

9. PRIZE COMPETITION FUND.

9.1. The Competition Organizer is responsible for the formation and presentation of the prize fund. The prize fund is not related to the payment of the Contestants.

9.2. The prize fund of the Competition includes:

9.2.1. 1st place in each category – gift certificate by OZON online shop for the deposit of 10 000 roubles

9.2.2. 2nd place in each category – gift certificate by OZON online shop for the deposit of 5 000 roubles

9.2.3. 3rd place in each category – gift certificate by OZON online shop for the deposit of 2 000 roubles

9.2.4. 10 participants in each category chosen by the jury will be awarded with gift certificate by OZON online shop for the deposit of 500 roubles

9.3. The cash equivalent of the prize value is not paid out or replaced with other prizes.

9.5. Prizes are awarded within the time period specified in clause 3.3 of these Rules.

9.6. Communication with the winner of the Competition is carried out by sending an information message to the email address specified by him during registration for participation in the Competition .

11. COPYRIGHT.

11.1. Each Participant guarantees that he is the author of the submitted works .

11.2. The participant also guarantees that the use of the works does not violate the rights of other participants or any rights of third parties (including copyright and related rights, as well as rights to means of individualization).

11.3. Participants of the Competition who took part in the competition in accordance with clause 7.1. of these Rules, and recognized as Winners, transfer to the Organizer exclusive rights in full (alienation) for use on the territory of all countries of the world (Art. 1234, Art. 1270 and Art. 1285 of the Civil Code of the Russian Federation) to comments they send , as well as to any materials and works with the participation of the Winners, created by the Organizer or third parties attracted by him as part of the Prize delivery process, for a fee in the form of Prizes received by him.

11.4. In the event that any claims and / or claims are presented to the Organizer by third parties in connection with the illegal use of the work , the Participant undertakes to independently settle such claims and / or claims in full, relieving the Organizer of liability, including from any payments to such persons.

11.5. The Participant of the Competition is responsible for violation of copyright and other rights of third parties in accordance with the current legislation of the Russian Federation. The Organizer of the Competition is not responsible for the violation by the Participant of the Competition, any visitor to the site of copyright and / or other rights of third parties.

12. PERSONAL DATA.

12.1. The fact of participation in the Contest is the consent of the Participant to the processing of personal data by the Organizer himself or by the persons involved by him in strict accordance with the purposes established by these Rules, as well as to the publication of the following personal data: surname, name, age, city of residence.

12.2. The purpose of the processing of personal data is to conduct a Competition in accordance with these Rules and applicable law.

12.3. The list of personal data that is provided by the Participant and processed by the Organizer or by persons involved by him is established and limited by these Rules.

12.4. The list of actions with the personal data provided by the Participants: collection, recording, systematization, accumulation, storage, clarification (updating, changing), extraction, use, transfer (distribution, provision, access), depersonalization, blocking, deletion, destruction of personal data.

12.5. Cross-border transfer of personal data within the framework of the Competition is not carried out.

12.6. The Organizer and the persons involved by him process the personal data of the Participants in strict accordance with the principles and rules established by the Federal Law of July 27, 2006 No. 152-ФЗ "On Personal Data", including confidentiality and security of personal data during their processing, including the requirements for protection established by Art. 19 of the named Law.

12.7. The organizer organizes the processing of personal data on the date of the Competition and further:

12.7.1. Without a time limit, the work of the contest participants is stored .

12.8. The Participant of the Competition has the right to revoke the permission to process personal data at any time by sending a written application by the Russian Post with a valuable letter describing the attachment to the Organizer's mailing address, which entails the automatic termination of participation in the Competition of a person who recalled his personal data.

13. ADDITIONAL CONDITIONS.

13.1. The fact of participation in the Competition implies familiarization of the Participant with these Rules and his consent to participate in the Competition in full accordance with these Rules, as well as consent to the provision of personal data.

13.2. The fact of participation of the Participant in the Competition implies his familiarization with these Rules and his consent to participate in the Competition in accordance with these Rules.

13.3. All Participants and Winners of the Competition shall independently pay all expenses incurred by them in connection with participation in the Competition.

13.4. The Organizer's obligations regarding the quality of the Prize are limited by the guarantees provided by their manufacturers (suppliers). Claims regarding the quality of the Prize must be made directly to the manufacturers of these Prizes. The integrity and functionality of the Prize must be verified by the Participants directly upon receipt of the Prize . The appearance of the original Prizes may differ from their image in advertising materials.

13.5. The organizer is not responsible for the quality of work and actions of third parties, including postal services. If the Gift sent by mail is lost or damaged due to the fault of the mail, which is confirmed by the relevant documents in accordance with the current Rules for the provision of postal services, the Organizer is not responsible for the loss of the Gift sent to the Participant.

13.6. The Organizer is not liable in case of sending the Gift to an incorrect or non-existent address due to the provision by the Participant of fuzzy or erroneous data.
