This is an e-tender. Vendors to ensure the bids are uploaded only through HAL E-portal under Two-Bid System

Sub : Request for Quotation(RFQ) for supply of Raw Materials for LCA MK II AF Programme.

HAL, a Navaratna Public Sector Undertaking under Government of India is engaged in Research, Design, Development, Manufacture and Repair & Overhaul of Aircraft, Helicopter, Aero-engines, Avionics and Accessories. The company has 20 production facilities and 10 R & D Centres. HAL has designed and developed various fixed wing aircraft which are being used by Indian Defence Services and Helicopters used for both Defence and Civilian applications.

1. **MATERIAL / QUANTITY REQUIREMENT:** The details of requirements indicating the material description, specification, size, quantity to be delivered, unit of supply etc are indicated at Annexure-III.
- 2.1 Please quote the requirement through HAL E-procurement Portal i.e. <https://eproc.hal-india.co.in> only. You have to submit your offer under 2-bid system.
- 2.2 Quotes submitted through any other mode such as Fax/E-mail/Post/Courier etc., will be summarily rejected. Please upload any additional data (except Price details) if any, in pdf format.
- 2.3 Bidders are advised to ensure that they have submitted the bids through E-procurement portal well before due date and time of tender. HAL e-portal will not allow submission of bids after closing date & time of tender. HAL shall not be responsible if bidder is not able to submit the bid on account of system/network/internet failures. Hence we request you to submit the bids well before the due date and time of tender.

Vendors need to get registered with HAL e- Procurement portal to submit their bids on line. Bidders should have valid Digital Signature Certificate(DSC) and registration with HAL's e-procurement portal for submission of bids.

3. Guidelines for submission of bids:

Vendor should submit proposal in 2 (Two) bid format, Technical cum non price bid and Price bid separately (through HAL e-Procurement portal only). Accordingly, your proposal should cover the following:

3.1 Technical cum non price Bid (Ref Annexure-III of this RFQ):

a) Vendors to submit the Technical Bid with compliance/complete details item wise as called for in **Annexure-III**.

b) Compliance matrix against Commercial terms and conditions at **Annexure-V** without any price details, should be uploaded along with the technical cum non price bid in the technical bid zone.

Note:

1) Bidders should download the Annexure-III (Technical cum non price Bid) excel sheet, Annexure-V (Commercial terms and conditions compliance matrix) excel sheet, from e-procurement portal and after the bidder fills their compliance/required data in the excel sheets (Annexure-III and Annexure-V), the same should be uploaded in the e-portal

2) Please note, in case of any price information provided in Technical Bid zone, even in the form of PDF, the Technical Bid would not be considered for evaluation and treated as invalid and will be rejected.

3.2 Price Bid:

It should be ensured that all prices/ values payable are specified in the Price Format at **Annexure-IV**. No subsequent addition/ alteration/claim will be entertained over and above the quote.

Note:

All prices should be filled in the Annex-IV excel sheet downloaded from e-procurement portal and the same should be uploaded in the e-portal. Prices should not be indicated in any other places.

4. Integrity Pact:

Bidder's participating in the tender has to submit the Integrity Pact (IP) as per HAL Format. The detailed Integrity Pact clause is indicated at clause no. 6 of **Annexure-V (Commercial terms and conditions compliance matrix)**. Bidder's has to go through the Integrity Pact clause in detail and submit the IP accordingly.

5. Bid opening:

i. **Technical cum non price Bid Opening:**

Technical cum non price bid against this RFQ would be opened on **24th Dec 2025, 10.30 Hrs (IST)**. All interested bidders may witness the tender opening online by logging into HAL e-Procurement portal. In case of any administrative issues for opening the technical bids on the proposed day, the technical bid will be opened on the next working day / following day.

ii. **Price Bid Opening:**

Price bids of short listed vendors whose technical bids have been found to be meeting HAL's requirement at least for one item, would be opened online. The information regarding date and time of opening, would be provided separately to only successful vendors. Technically qualified bidders may witness the tender opening online by logging in to HAL e-Procurement portal.

6. **Restrictions on procurement from Bidders from a country which shares a land border with India.**

Department of Expenditure has issued Office Memorandum no. 6/18/2019-PPD dtd. 23.07.2020 by amending the Fundamental Principle of Public Buying by inserting sub rule 144(xi) in the General Financial Rules(GFRs) 2017 by imposing restriction in procurement, including prior registration or screening on procurement from bidders from a country or countries on grounds of Defence of India and National Security. As per the amended rule no public procurement shall be made in violation of such restriction.

Any bidder from a country which shares a land border with India and the Government of India has not extended lines of credit or in which the Government of India has not engaged in development projects is not eligible to bid in any procurement (i.e. goods, services & works). However, the bidders from that country is eligible only if the bidder is registered with the Competent Authority (i.e the registration committee constituted by the Department for Promotion of Industry and Internal Trade(DPIIT)). [Note: The information on countries having Lines of Credit notified by Ministry of External Affairs(MEA) is available at <https://meacms.mea.gov.in/lost-of-countries-loc-extended.html>. However, this aspect has to be confirmed by the Bidder by submitting the Declaration Certificate]

The Clause regarding restrictions on procurement from a bidder of a country which shares a land border with India is enclosed at **Annexure-I. DECLARATION CERTIFICATE FOR PROCUREMENT OF GOODS & SERVICES** is enclosed **Annexure-IIA and Annexure-IIC**. The Bidders need to fill / sign the Declaration Certificate and submit the same along with the technical bid.

7. HAL has not appointed any agent in India or outside India for procurement of any Items and deals directly with vendors. In case, any individual or firm approaches you Posing themselves as an authorized agent of HAL, it is requested that you should not entertain and shall bring such instances to the notice of HAL Management.

8. Additional Information:

i. Please note that offers (In English Language only) to be uploaded / submitted within the due date and time as mentioned in the tender. Further, offers received in the form of Hard copy (courier/post/dropping in tender box) / E-mail / Fax or any other mode will not be considered and will be rejected.


iv. HAL will not be responsible for the cost incurred in preparation & submission of bids including the cost towards obtaining digital certificate.
