Notice Inviting Bids

The Embassy of India School, Moscow invites bids from interested entities for FIXING LED TUBE LIGHTS in our School as per the following specifications:

- 1. Replacement of old unserviceable tube lights into LED tubelights.
- 2. 167 LED tube light sets (2 bulbs in one set) are to be installed.
- 3. LED tubelights are to be installed in the class rooms, corridors and office.
- 2. The payment shall be done subsequent to the replacement of the all the above said unserviceable tube lights into LED tube light sets as per the locations and the quoted price should include the cost of delivery of the material, labour charges and disposal of garbage.
- 3. Interested parties may visit the School for ascertaining the suitability and requirement of this Institution from 27.11.2018 to 04.12.2018. This would help the interested suppliers to formulate their quotation. A prior appointment should be made with the office of the Embassy of India School (Tel. No (499) 240-64-37) for this purpose.
- 4. Suppliers are required to submit their bids in a sealed envelope describing in detail the specifications (especially material, labour charges and disposal of garbage after the replacement of tube lights). The bids should be valid for a peroid of three months from the date of the opening of bids.
- 5. The sealed envelope should be submitted to the attention of the Principal, Embassy of India school, Moscow by 05.12.2018 accompanied with the proof of payment of Rbls. 20000/- to the Embassy of India School, Moscow vide bank transfer (Bank details can be obtained from the school office while visiting the site for inspection). The amount of Rbls. 20000/- will be treated as earnest money deposit/bid security and would be returned to all the unsuccessful bidders within 30 days after finalization of the contract with the successful bidder.
- 6. The successful bidder shall be obliged to deposit an amount equivalent to 5% of the value of the contract to be awarded as performance security. The performance security shall remain valid for a peroid of 60 days the completion of all contractual obligations of the bidder. The bid security shall be refunded to the successful bidder on the receipt of the performance security.
- 7. Representatives of all the bidding parties can be present at the time of the opening of the bids. The bids shall be opened on 05.12.2018 at 10.30hrs at the Embassy of India School, Moscow, 10/2 Bolshaya Dorogomilovskaya. The work shall be offered to the lowest bidding party.
